Dear Mrs. Brusarosco,

Thank you for your letter dated April 30, 2001 which we received via Marieke van Hal, together with the financial report of the exhibition .nl.

We gladly accept the report on the contents of the exhibition itself but unfortunately we do not accept the financial report.

Our grant covered travelcosts, accommodation, sejour, transport and insurance of works and part of the publication, respectively *f* 4.400, *f* 5.700, *f* 2.850, *f* 12.500 and *f* 3.550 totaled *f* 29.000.

We compared the received information with this original budget and come to the following conclusion on which we will settle our grant:

Travelcosts *f* 5.162, accommodation *f* 4.977, <sup>3150</sup> sejour *f* 2.850 (as budgeted), transport *f* 6.325 and the same part of the publication *f* 3.550 which totals and rounded up *f* 23.000.

We do not accept the invoice from Marieke van Hal that made the publication more expensive as compared to the budget. All the extra costs for production, press etc. are not relevant for our grant. Furthermore we would like to add that in some of the invoices BTW (=VAT) is included and those are no costs to you.

In the end we would like you to know that we are settling this project although the financial report does not meet the terms which are contingent to our support. Copies of invoices should all be in your name and have to be accompanied by proofs of payment by copies of bankstatements.

You have received two advance payments of *f* 7.500 each and therefore we will transfer the remaining amount of our grant, being *f* 8.000, as soon as possible into your bankaccount 70273230106 with the Banca Commerciale Italiana, ag. 7 (routing ABI 2002 CAB 1607) in Milan with as reference BKVN 6662/01.7.
